From Manhattan and other points south:

- Take the Major Deegan North into the New York State Thruway (Route 87N).
 - Take Exit 17 Off the NYS Thruway to Interstate 84 East
 - Take Exit 13 Off Interstate 84 East
 - Turn left of I-84, the hotel is located 100 yards down street (Route 9) on your right

From New Jersey, Rockland, and other points west:

- Take NYS Thruway North to Exit 17
